### Eagle Brand Magic Cookie Bars

#### Ingredients

- 1 stick butter
- 2 cups crushed graham crackers
- 12 ounces semi-sweet chocolate chips
- 12 ounces butterscotch baking chips
- 14 ounce can sweetened condensed milk
- 1 cup shredded coconut
- 1 cup pecans chopped



#### Instructions

- Preheat oven to 350 F. Melt stick of butter in 9 X 13 inch pan. Sprinkle graham crackers crumbs evenly over melted butter, mix and press evenly into pan.
- Pour can of Eagle Brand sweetened condensed milk over unbacked crust.
- Sprinkle baking chips, coconut and pecans evenly over milk.
- Bake for 20 minutes. The edges will be golden brown when the cookies are done.
