

Sierra Solar Energy Facility Project

The board of trustees of Sierra Electric has been working on an agreement with Affordable Solar to install a 960 kW solar energy facility in Sierra County to benefit the members of Sierra Electric Cooperative (SEC). About June of 2017, SEC board president John Bokich formed a board committee to see if bringing a large scale solar project would be feasible and desirable. Bokich appointed board member Tom Stroup to head this committee, and Tom in his usual fashion has been full steam ahead for the past several months.

The process is much more complicated than any of us anticipated, and Tom has worked diligently and tirelessly with Affordable Solar and the attorney representing the New Mexico Rural Electric Cooperative Association, Dan Najjar, to get the language right in the contract between SEC and Affordable Solar.

The solar energy facility will be a photovoltaic power station designed for the supply of power into the electricity grid, and offset some of the electricity we currently purchase from Tri-State G&T. Innovations like this renewable energy project, along with the growing renewable portfolio of our wholesale power supplier, Tri-State G & T, who is the largest provider of renewable electricity of any generation and transmission company in the U.S., will help ensure that Sierra Electric continues to provide safe, affordable and reliable power to our members.

The contract negotiations are nearing the end of a 10-month process, and we are hoping that we can start construction soon and bring this important project to reality sometime in the fall or winter of 2018.

Spring Landscaping Safety and 811 - Call Before You Dig

If you are going to be doing digging—ANY kind of digging, whether it is for planting trees, building a fence or installing a mailbox—always start with a phone call to 811—Call Before You Dig two days before you plan to dig. 811 operators will contact the utilities in your area and they will send a locator to mark the approximate location of your underground utility lines. The marks are valid for 10 days.

The best pal you ever did see.


So sometimes in a thunder storm,
